# Move for your Heart (

If you're inactive, you're nearly twice as likely to develop heart disease than if you're active. Being active can:

- Protect your heart (even if you have heart disease)
- Improve blood flow
- Lower blood pressure and cholesterol levels
- Give you more stamina and ability to cope with stress



Only have 10 minutes? Consider: --Walking briskly for 5 minutes, turning around and walking back --Dancing (standing or seated)

--Getting off your bus early and walking the last stretch

You'll know you're moving enough to help your heart if: -Your heart is beating faster -You're breathing harder -You break a sweat -Or, try the talk test: During physical activities, like brisk walking, you should be able to talk, but not sing.

- Older adults who do ANY amount of physical activity gain some health benefits. If inactive, older adults should gradually increase their activity levels and avoid vigorous activity at first.
- Do a variety of activities. (Walking has been shown to provide health benefits and a low risk of injury.)
  Some physical activity is better than none. Inactive adults should gradually increase their level of activity. Be as physically active as your abilities and condition allow.
- People gain health benefits from as little as 60 minutes of moderate-intensity aerobic activity per week. For major health benefits, do at least 150 minutes (2 hours and 30 minutes) of moderateintensity aerobic activity.
- You should do balance exercises if you're at risk for falls, as well as aerobic and bone-strengthening activities. Examples include walking backward or sideways, standing on one leg, and standing from a sitting position several times in a row.
- If you have a chronic (ongoing) condition such as heart disease, lung disease, or diabetes – ask your doctor what types and amounts of activity are safe for you.

Try these tips to make being active part of your everyday routine:

## Add a friend or family member 7

Take a yoga or other fitness class online with a friend.
Share your fitness goals with your spouse or roommate.

• Commit to a walking schedule with a friend or family member, even if you can't walk together.

#### Do what you love

· If you enjoy the outdoors, try biking, hiking, golf, or gardening.

• Play with the children in your life.

Check out the track at a nearby school.

Think of physical activity as a special time to refresh your body and mind.

#### Build activities into your day

Do strength exercises while watching TV.
 Take a walk during lunch.

• Go for a walk or a bike ride before you sit down to enjoy dinner or a movie.



# **Obesity, Sugar and Heart Health**

Over the last half century, obesity rates have skyrocketed. In 1962, 46 percent of adults in the U.S. were considered overweight or obese. By 2010, that figure had jumped to 75 percent. Obesity is a comp lex problem with multip le causes. But among the likely suspects, sugar is high on the list. As sugar consumption has increased, so too has our national waist-line. If you're concerned about protecting your health and your heart, you might want to take a closer look at the sweet stuff in your life.

# DOES SUGAR CONTRIBUTE TO WEIGHT GAIN?

The average American eats a whopping 20 teaspoons of sugar every day, according to U.S. government figures. That's well above the American Heart Association's recommendation of 6 teaspoons per day for women and 9 per day for men. A variety of research has drawn a link between sugar consumption and excess body weight. All those sweet snacks seem to be affecting the heart as well, researchers compared peop le who consumed a lot of added sugar, with peop le who ate less sugar, those in the high-sugar group had a 38 percent greater risk of dying from heart disease .

# THE OBESITY-HEART DISEASE LINK

Excess weight increases the risk of high blood pressure, high cholesterol and Type 2 diabetes. Research has shown that those factors usually exp lain the link between obesity and heart disease. All of those factors make it more likely that someone will develop cardiovascular disease. However, obesity itself can be harmful even in the absence of those other conditions. Researchers found that after accounting for factors such as high blood pressure, high cholesterol and diabetes, obesity by itself increases the risk of heart failure. In other words, there are many reasons to aim for a healthy weight. And cutting back on sugar is a good p lace to start.






#### Warm, Healthy and Decedent!

#### Cafe Mocha

Nothing warms you inside and out like a good cup of hot chocolate, coffee, or tea on a cold day. This recipe incorporates pantry items you already have on hand and uses them to make a rich, delicious hot beverage. Ingredients



- 1 cup water
- 1 cup coffee (brewed)
- 4 tablespoons hot chocolate mix
- whipped topping (non-fat, optional)
- cinnamon (optional)

#### Directions

- Heat reconstituted non-fat dried milk in saucepan until warm; do not boil.
- Add coffee and hot chocolate mix. Stir well and heat to desired temperature.
- 3. Divide coffee mixture between two mugs. Top with non-fat whipped topping and cinnamon, if desired. Serves 2.

#### Notes

You can substitute 1 cup skim milk for the reconstituted non-fat dried milk.

#### Awesome Granola

#### Ingredients

- 3 cups oatmeal (unccoked)
- 1/2 cup coconut (shredded or flaked)
- 1 cup pecans (chopped, walnuts or peanuts)
- 1/4 cup honey
- 1/4 cup margarine (liquid)
- 1 1/2 teaspoons cinnamon
- 2/3 cup raisins

#### Directions

- Heat oven to 350° F. Combine all ingredients in a large bowl, except raisins, mix well.
- Bake in 13x9 inch baking pan at 350°F for 25- 30 minutes or until golden brown. Stir every 5 minutes.
- Stir in raisins. Cool thoroughly. Store in tightly covered container. 3. Place onto un-greased cookie sheet or aluminum foil to cool. Cool

# **Overnight Oatmeal** with Berries

#### Ingredients

- 1/2 cup low-fat milk (or less for thicker oatmeal)
- 1/4 cup Greek yogurt, fat-free
- 2 teaspoons honey
- 1/4 teaspoon cinnamon
- 1/4 teaspoon vanilla extract
- 1/2 cup uncooked rolled oats
- 1/4 cup raspberries, frozen

#### Directions

- Combine milk, Greek yogurt, sugar, cinnamon and vanilla extract in a container or iar with a lid.
- Add oats and mix well.
- Gently fold in raspberries. 3.
- Cover and refrigerate 8 hours to overnight. 4.
- 5. Enjoy cold or heat as desired.

#### Notes

Frozen blueberries or strawberries may be used in place of raspberries.

- 1/3 cup brown sugar (packed) 1/4 cup whole wheat flour

#### Directions Filling:


- Combine sugar, flour, and lemon peel in a medium bowl and mix well. 1

- Spoon into a 6-cup baking dish. 3.

#### Topping:

- Combine oats, brown sugar, flour, and cinnamon in a small bowl. 1
- 2. Stir in melted margarine.
- Sprinkle topping over filling. 3.
- Bake at 375 degrees for 40 minutes or until filling is bubbly and 4. top is brown.
- Serve warm or at room temperature. 5.

# **BUILDING:**

Permits Issued: 4 Total Inspections: 6 (mainly at the hospital)

Demolition Permit issued for 1487 E. 2<sup>nd</sup> St., property has been sold and new owner is demolishing old mobile home on property, and will be building a new home in the future. Should be noted that the Town has been trying to get this mobile home demolished for a long time and it was the subject of various code enforcement issues.

There is a new business going in at 20 W. Main Street (the old Honey Shack), it will be a pet grooming business, they have an inspection scheduled next week so that they can get their C of O.

# **CODE ENFORCEMENT:**

Working on getting written correspondence to some residences around town where issues have been reported.

# PLANNING AND ZONING COMMISSION:

<u>March 12, Meeting:</u> The Commission is continuing their review of Title 17, they are going to hold off on some areas until the joint Animal Control ordinance is complete before making major changes to ensure no conflicts. They also are being brought old Conditional Use Permits to review, and in some cases officially revoke them. At this last meeting they reviewed and revoked the following:

- 242 E Main Street (old Speckled Trout building)-CUP was issued for a medical marijuana dispensary April 2013, the business never officially opened and CUP was never utilized
- 65 N D St, CUP was issued for a veterinary clinic in October 2014, the property has since sold and is now a church.

upcoming transportation and events he will be doing for the seniors. They plan to provide transportation to the Renaissance Festival in March and a trip to the Cat-Walk and Silver City this summer. He updated on the much needed transportation services he and Tony are helping to provide to the community and how it is improving seniors quality of life.

## 5. COUNCIL, MANAGER AND STAFF REPORTS:

## a. Mayor & Council Reports: Summary Updates on committee meetings.

## Minutes:

Mayor Reidhead explained she has attended multiple meetings for coal transition. She also updated that Maverick should be closing escrow in the next 3 - 4 weeks.

## b. Staff Reports: Summary Updates

#### Minutes:

Robin Aguero, the Community Services Director gave an update on current staffing, services being provided, grants, and who is receiving these services. She currently has 2 full-time employees, 5 part-time employees, numerous volunteers, and two inmates. She showed the data with increases to meals being provided including Meals on Wheels, Head Start, and Congregate. She next showed the increase in transportation services being provided. They hosted a volunteer appreciation, collectively the volunteers provided 1261 volunteer hours. She explained the low-income assistance including rental deposits & assistance, utility assistance & deposits, food & fuel cards, bus passes, and appliance assistance. The majority of the financial assistance for most categories are Eagar residents. Lastly, she updated on the March for Meals fundraiser on March 30, 2024.

Robert Pena, the Public Works Director reported they have had a very eventful month. The vacant position has been filled, the new employee has hit the ground running. AMR meters are moving forward, the request for bids is being created and will hopefully go out in a few weeks. Next, he updated that they are working on GIS, road & pothole patching, the water model, and fueling at the airport. He pointed out how appreciative he is for Kevin working through multiple issues with the fuel truck and going above and beyond to get that going, all while keeping up with the equipment and vehicles. Next, he reported Kevin and Fred went and talked to the kids at the elementary school and enjoyed talking to the kids. Kelsi Miller, the Town clerk updated on the upcoming election. House Bill 2785 changed the

Primary Election date to July 30, 2024. This changed the filing period deadline to April 1, 2024. She reported the new website is coming along and we hope to go live with it in early March.

Levi Penrod, the Round Valley Fire Department Chief reported on recent activity for the fire department. It has been a little over a year since the departments merged. They responded to about 500 calls within that year including medical, wildland fires, and structure fires. The total personnel is 28 with 4 full-time employees. He updated on getting staff certified as both EMTs and Paramedics. Last year they were able to deploy a crew on some wildland fire assignments bringing in a profit of \$47,000. They focused on training this past year getting employees trained as FF1, FF2, and certified to shoot fireworks. They reported on a grant for an ambulance has been awarded in the amount of \$250,000. The build and purchase of that will be a year out. Chief Penrod also updated on grants from TEP and the 100 Club.

Lastly, he reported on waiting on engineered plans for a new fire station.

## c. Manager Tim Rasmussen: Summary Updates & presentation(s)

## Minutes:

Manager Rasmussen updated the Council on recent projects and activities at Town Hall. He updated that the Town has received 600 new coats and shoes in various sizes for kids in the community. We will be handing them out around the holidays next year along with toys donated from Toys for Tots. He thanked Kevin Plympton the mechanic for all of his help with the fuel truck issues. The fuel truck is no longer being leased from World Fuel, the town has been given the title. They chose this option over repairing the truck. Kevin was able to fix the issues and get it running. We now have a truck worth \$20,000 free and clear. We will consider investing in an updated one in the future, Manny has great connections and has helped increase fuel sales. Next Manager Rasmussen informed them that the new logo is coming along, Maverick has received the ADOT approvals, and both managers of Springerville and Eagar have worked on the IGA for animal control. The IGA has now been forwarded to the two town attorneys to work together on the legal language.

# 7. PRESENTATION : Lava Run Wind and Solar Projects

# Minutes:

Trinidad Kechkian and Henry Woltag with ConnectGEN presented the Lava Run Wind and Solar Project to the Council and the public. They explained they are a renewable energy source company with projects throughout the U.S.. ConnectGen is going through the process of proposing a wind project northwest of Springerville and a solar project northeast of Springerville. They reviewed both projects with the Council and proposed operations date of 2027. They explained why they chose Apache County, and explained it's compatibility to the project. The local benefits of the project were discussed including short-term employment for construction and longterm employment. It was discussed the importance of community engagement and keeping those conversations open. Lastly, they reviewed the proposed timeline they are going to try to follow. The council and the public asked them questions regarding the project. It was asked where the power would be stored. They informed them onsite. They asked if the power would stay local or shipped to the cities. They explained they partner with TEP and where the TEP system sends it is up to them. They discussed the life of the project is only 35 years and it was discussed what happens when they are done with the wind farm and solar systems. It was asked how many wind turbines would go up. It is estimated around 100. They discussed how the project runs off of a SCADA system. Council asked about the habitat study and how they will mitigate bird endangerment. They said they have been working with Fish and Wildlife to ensure meeting all setbacks from nests.




### **STAFF REPORT**


In years past, the Town has had a utility easement issue with some areas of town and certain residences. Water lines, meters, and sewer lines are built in utility easements. These utility easements need to have access to the Town for meter reading, maintenance, installation and replacement of lines or meters, and for water breaks or sewer issues.

With the Grant from WIFA for new AMR (Automatic Meter Reading) meters, new meters need to be installed. We have areas in town where we do not have access to replace them with equipment as property owners have fenced over the utility easement. One of our biggest areas of issues is the El Cajon/ Hacienda in El Cajon Estates. Employees are having to jump over fences to read meters. Employees have been bitten by dogs and it upsets some residents that employees are jumping over their fences if they have no access. If a water break ever happened in this area, fences would have to be dismantled and equipment would be brought into what people consider their back yards.

With the need to install new meters, I have asked Mr. Kavanagh to help us draft a letter to the residents that they have to move their fence lines back 10' to create an alley way that is a dedicated utility easement. Mr. Pena and I would like to confront this existing issue that the Town has had for many years. We are looking for support as it may upset some citizens to be losing 10' of their back yard.

Mr. Kavanagh has put forward some questions that I would like to discuss tonight and answer them. Please see attached e-mail correspondence between us both.

We are happy to help with letters. Here are some of my initial thoughts and questions:

1. Adverse possession and prescriptive easements do not work against sovereign entities, but many people won't know that and may try to say that their fences have been up for years. How long has this been an issue and why didn't the town send letters before (or can I get copies of any letters sent before)?

2. I see that the plat says 1978 and it says the streets are publicly dedicated. It also says easements for the purposes noted. I am having a hard time reading the plat to see if it notes anywhere what easement rights apply to the alleyway areas. Are we just relying on the small depiction that says "typical back lot line utility easement"?

3. If all we are relying on is the plat, then I take it that there are no other documents noting that people are not to block access. That is fine, I just want to know if this is the extent of our "easement universe" to work from.

4. What is the "or else" threat? Are we saying that people have to move their fences or they are cut off from utilities service? That you will tear the fences down and not build replacements? Or will you sue them to get an injunction to make them take down their fences?

### Good Morning.

We wrote a grant for AMR's (Automatic Meter Reading) and received the grant. We will be installing new meters to every residence using heavy equipment. We have a problematic area and an issue that the town needed to take care of for many years. Since we need to install new meters, this is the right time. We have a 20' utility easement in between houses and an alley way should have been created but the residences built their fence lines to the property line alleviating the alley way for the two 10' easements. Please see attached map. I highlighted in yellow the easements. We have had to jump fence lines to read meters. Employees have been bit by dogs and residences get angry when we jump their fences. If or when a water line breaks, we would have no ability to get employees and equipment down the easement.

We would like to create a letter to send to the residences and enforce them to move their fence lines back 10'. Do you have any advice in this process? Can you help us with the letter and process?



We obtained an appraisal of the property and buildings. As a result of the investigation and analysis by Sell and Associates, they determined that the market value is \$250,000. The "Fair Market Value" is \$250,000 and would be the minimum starting bid in a sealed bid process that is advertised.

The Town of Eagar will do the sealed bid process if you approve the sale. The Town of Springerville cleaned up the property, a roof was replaced, replaced rotting fascia, and got the appraisal.
