

TOWN COUNCIL REGULAR MEETING MINUTES

4. **PUBLIC PARTICIPATION:**

Becky Christensen with the Springerville - Eagar Regional Chamber of Commerce addressed the Mayor and Council. She updated on advertisements for Springerville and Eagar in the valley area. She told Council about upcoming events including a mother / daughter tea party in May at Lyman Lake, classic car show called rods & hogs, a hot air balloon festival in August, and a St. Patricks Day mixer at Averys.

Terry Shove addressed the Mayor & Council. She let them know about a Dr. Suess reading event at the elementary school in February and March. Council is invited to come read with third-graders. She next updated on Little League Basketball. The season is going well, they have 306 kids playing this year. They have 19 teams from St. Johns, 18 teams from Round Valley, and 1 team from Quemado. Lastly, she updated that the wrestling teams are going to a state tournament in Prescott.

Lane Scott, a builder, addressed the Mayor and Council. He discussed the concerns around the country and the lack of affordable housing. He builds not only tiny houses but tiny villages that have shops and houses to create a community. He gave Council his brochure if they are interested.

The audit presentation included a five year comparison of the general fund and its net position, and the five year comparison of the utility fund and its net position. All funds have increased in health over the last five years.

A builder contacted us wanted to extend the main off of Becker Lane. He is willing to provide the funds for the main. Mayor Reidhead asked if we know how many meters they are looking to connect. He explained initially it would be 3, but we could also do some clean up on other lines there and connect them to the main. It was explained there is a possibility of looping and circling this main back into itself. Mr. Christensen asked Council to consider his suggestion of allowing these main extensions at his discretion. Mayor Reidhead said she would like Council to visit main extensions on a case by case basis, Councilor Scott agreed.

17. APACHE-SITGREAVES NF AIRBASE LEASE RENEWAL:
